

**EAST CARTERET HIGH SCHOOL  
STUDENT VEHICLE CONTRACT**

I understand that the operations of student vehicles on school grounds are privileges. In consideration thereof, I agree to abide by the following terms and conditions:

1. I will park my car immediately upon arrival on campus and not return to my car until I leave campus at the end of the school day.
2. I will permanently mount my parking permit in the designated place, on the windshield behind the rear view mirror.
3. I will drive cautiously and not exceed the speed limit. I understand that I may be charged for any violation of the law, such as, exceeding a safe speed, careless and reckless driving, etc. The school resource officer can write citations for violations.
4. I will obey all rules, laws, and regulations pertaining to the operation and parking of a motor vehicle as established by the state, county, school system, and my high school.
5. I will not bring onto the school ground, nor keep in my vehicle while it is on the school grounds, any prohibited controlled substances such as beer, wine, alcohol or any other drugs, nor any guns, weapons, or explosives.
6. I understand that school officials have the authority to open, enter, and search my vehicle if they have reasonable suspicion that any of the items described in #5 are in my vehicle. I will allow school officials to remove such item as evidence in school disciplinary proceedings or as evidence in a criminal prosecution.
7. I understand that I can transfer my sticker to another vehicle if I make the necessary arrangements with the person in charge of parking permits. A replacement parking pass will be \$15.00.
8. I understand that I may loose my parking privileges for the following violations: failure to display my parking permit, parking in the bus or faculty parking areas, blocking other vehicles, driving recklessly, speeding, falsely registering or altering the registration of a vehicle, driving on restricted areas such as grass or walkways, or accidents.
9. I understand that my vehicle may be towed if I park in restricted areas. **THE TOWING COST IS MY RESPONSIBILITY!!**
10. I understand that my parking privileges will be revoked for the remainder of the school year upon my receipt of the second violation.
11. I must have my completed Parking Registration Information Form and \$15.00 to purchase a parking permit.
12. I understand that I will not be permitted to go back and forth to my vehicle during the school day. I cannot use it as a locker or allow others to do so.
13. I will not permit people to sit in my vehicle during the school day.
14. I will keep my vehicle locked at all times. I understand that the school system and the officials are not responsible for my vehicle and its content.
15. I understand that my car is to be parked in the student parking lot when I am on campus. I know that I am not to move my car because I have practice after school, or go out of town with an activity group.
16. **TICKETS** will be issued for parking violations of any of the above guidelines at the cost of \$10.00.
